Minimum Cost: \$6.500.00

Replace:

Implement the Crane Industry Council Australia CrewSafe system, a verification of a competency assessment tool designed for the Australian crane industry. CrewSafe is a standardised assessment program that is machine specific, impartial, peer assessed, and independently verified.

Implementation of CrewSafe will allow Crane Services Pty Ltd to identify areas for improvement and provide targeted training to enhance their crane operator's skills and performance.

To demonstrate compliance with the proposed variation, within six months of this variation being accepted Crane Servies Pty Ltd commit to 47 crane operators completing a competency assessment for one crane per operator within the CrewSafe system.

The cost for the initial implementation of CrewSafe is \$13,000.00 with ongoing costs of \$165 for new operators (sign-up fee) with two cranes and \$50 per additional crane.

Minimum Cost: \$6,500.00

Replace:

Implement the CICA CrewSafe system, a verification of competency assessment tool designed for the Australian crane industry. CrewSafe is a standardised assessment program that is machine specific, impartial, peer assessed and independently verified.

The competencies obtained through CrewSafe follow the operator, they do not stay with the company. Therefore, as operators move around within the industry, the benefits are industry wide. This model will provide confidence that companies are hiring competent operators with the skill set needed for safe crane operations.

To demonstrate compliance with the proposed variation, within six months of this variation being accepted Crane Servies Pty Ltd commit to 47 crane operators completing a competency assessment for one crane per operator within the CrewSafe system.
