Enforceable undertakings will not be removed from the public register and will remain on the register after a company or individual has discharged all obligations of the undertaking.

### 1.2 Details of the alleged contravention

While no formal contravention of the *Work Health and Safety Act 2012* (SA) (the Act) has been alleged, Koch Farming understands the correct characterisation to be the following with respect to a worker and an incident involving a Case Skid Steer at its Stockport farm on 26 March 2020:

- Section 13 of the Act in that it had the duty prescribed by Section 19(3)(b)(f) of the Act to ensure, so far as was reasonably practicable, (b) the provision and maintenance of safe plant and structures; and the provision of any information, training, instruction or supervision that is necessary to protect all persons from risks to their health and safety arising from work carried out as part of the conduct of the business or undertaking.
- Additionally, non-compliance with respect to regulations 213, 29 and 35 of the Work Health and Safety Regulations 2012 (SA) (the Regulations).
- 1.3 Detail the events surrounding the alleged contravention

On the 26<sup>th</sup> of March 2020, a full time worker employed by Koch Farming was involved in an workplace incident on our farming property located at 220 Observatory Road, Stockport where he was overrun by a Case Skid Steer loader which is owned by Koch Farming.

The worker sustained a notifiable serious injury to his pelvic area (fracture) requiring immediate treatment as an in-patient in a hospital. The worker also sustained the following injuries:

- a broken rib
- > deep cut to right thigh

- two fractured toes on left foot
- bruising and swelling to left foot, left arm, left elbow and left wrist

1.8 Detail any current work, health and safety systems at the workplace Koch Farming has implemented the Safe Ag Systems app based program since the incident and in response to the Improvement Notices. The Safe Ag Systems program is a complete safety management and recording system for Agribusinesses. Features include:

- Policies and procedures to establish our safety goals and expectations
- Safety checklists for machinery and infrastructure.
- Inventory management. Manage and record servicing/repairs of machinery and infastructure
- Reporting of training and inductions of workers
- Emergency Management
- Near Miss and incident reporting
- Safety inspection checklists and reporting to identify and manage potential hazards

Outside of this program Koch Farming have also developed a series of seasonal safety checklists to help identify any potential hazards or safety issues. Tractors are inspected 6 monthly for general safety and operation by a Director of Koch Farming, any issues are recorded and rectified. Likewise, harvest machinery, hay machinery and seeding machinery have similar checklists. For example before hay season, the mower, hay rake and baler are inspected by the Directors of Koch Farming and aspects are recorded on an inspection checklist and rectified.

1.9 Detail the level of auditing currently undertaken on the work, health and safety systems referred to in term 1.8, including compliance audits and audit frequency

Koch Farming does not engage auditors on the work, health and safety systems. The Directors conduct and review the work, health and safety responsibilities.

Koch Farming will review its work, health and safety performance annually using the quick safety scans that are detailed in the 'Farmers Guidebook" on the Safework SA internet page.

Internally, 6 monthly general safety and operation inspections on tractors as well as seasonal safety and operation inspections for major plant and equipment will be carried out by the Directors.

1.10 Detail the consultation undertaken or proposed to be undertaken, in relation to this undertaking

As a business we commit to communicate and consult with all employees and workers, including contractors and seasonal employees on all aspects of our workplace health and safety policies.

The Directors are committed to consulting with other farm businesses in our local area through industry organisations about our experience with regard to the incident and resulting Enforceable Undertaking.

On behalf of Koch Farming, on 22 March 2021 a Director presented his experiences around workplace health and safety in front of the Owen Agricultural Bureau, an Agricultural information and networking forum that usually meets on a monthly basis. Twelve farm businesses were represented at this meeting where the Director spoke about the need for safety to be at the forefront of farm management discussions. A Copy of the Minutes of this meeting has been provided to the regulator.

On behalf of Koch Farming, on 16<sup>th</sup> September 2021, a Director once again presented his experiences around workplace health and safety with a focus on the Safe Ag Systems program implemented by the company. This presentation took place during a farming workshop attended by five farming businesses. These workshops form part of a broader farm management group which meets twice yearly. The workshop was facilitated by an Agronomy Team Leader and Partner at Pinion Advisory.

1.11 Detail the rectifications to the workplace or work practices made as a result of the alleged contravention and the enforcement notices issued Immediately following the incident and following notices issued by SafeWork SA Investigators, the skid steer loader involved in the incident was not operated or utilised. Koch Farming has disposed of the skid steer loader.

Koch farming registered with the Safe Ag Systems safety and training program as a way of registering and recording farm servicing, training and safety records - \$1650 p/a

Koch Farming developed four spreadsheets for safety inspection of Tractors and other plant and equipment.

Following a review of key safety issues on the farm by the Directors of Koch Farming, Koch Farming has made the following changes to plant and machinery:

- Portable field bins that do not have spring assisted wheel lifting devices and ground opening lids are no longer to be used as portable bins. They are to remain in situ in the farmyard and grain bought to that location to fill them. 2 new bins have been purchased for use as a portable bins \$25,960
- Older shearing plants have been retired and now only modern shearing plants with electrical safety cut-out switches are used.
- A brand-new grain auger was purchased. This auger is the main grain auger used for harvest operations. The auger has full guarding of moving parts, safety signage, electric brakes and lights for transport as well as ground drive to eliminate physical effort of shifting. \$25,997

- A second smaller auger was purchased for smaller jobs around the farm. This auger has full guarding and safety signage as well as braked manual lifting winch. \$7920
- A Polaris Ranger side by side vehicle was purchased as a replacement to a four wheel quad bike to undertake more safely jobs such as spot spraying, sheep mustering and general farm travel. The vehicle is equipped with seatbelts, Roll Over Protection Structure \$19,545

Koch Farming purchased 7 first aid kits, 2 larger kits to be placed in a workshop and shearing shed and 5 smaller kits for use in utes and tractors, also purchased were stickers to identify kit location. \$755

Koch Farming sincerely regrets that this incident has happened and is committed to mitigating the inherent risks that lie within our industry into the future. Agriculture has room for improvement with regard to workplace health and safety. Due to the busy seasonal nature of Agriculture many hazards can be overlooked or ignored. We believe that the actions that we have undertaken since the incident have greatly improved our workplace health and safety and will continue to into the future. The aim of sharing our experience with other farmers, is to provide awareness of the need to have workplace health and safety at the forefront of their business plans.

2.3 Statement of commitment that the behaviour, activities and other factors which caused or led to the alleged contravention has ceased and will not reoccur

Koch Farming is committed to ensuring that the behaviours and activities that led to the alleged contravention occurring have been rectified we are committed to avoiding accidents into the future.
